## **Doggie Daycare Playgroup Contract**

**THIS AGREEMENT is entered into by and between Coastal Kennels and the dog(s) Owner named at the bottom of the second page.**

### **BEHAVIORAL REQUIREMENTS:**

Owner understands and agrees that by admitting Owner's dog(s) to Coastal Kennels Doggie Daycare, that the staff has relied on Owner's representations that Owner's dog(s) have never harmed, shown aggression, or exhibited any threatening behavior towards any dog or person; This includes food aggression. An assessment will be conducted to help determine each dog(s) behavior before being admitted into the program. Coastal Kennels reserves the right to refuse a dog(s) if it appears to us that such dog(s) behavior could jeopardize the safety of other dog(s) or staff. \_\_\_\_\_(INITIALS)

### **HEALTH REQUIREMENTS:**

Coastal Kennels accepts dogs for participation with the understanding that the Owner's dog(s) are in good health. Dog(s) will not be admitted that do not appear to be in good health, have diarrhea, have skin conditions (i.e. hair loss, lesions, ect.), are coughing or sneezing. We do not require but recommend using a flea and tick control product (i.e. Frontline, Advantage, Trifexis, ect.). Any dog(s) with visible fleas will not be admitted. No guarantee of a "flea free" environment is made. \_\_\_\_\_(INITIALS)

Owner further understands that even if their dog(s) is vaccinated for Bordetella (Kennel Cough), there is a chance that contraction of Kennel Cough may occur, and Coastal Kennels will not be held responsible if Owner's dog(s) contract Kennel Cough. \_\_\_\_\_(INITIALS)

Owner must provide a certificate of sterility upon enrollment for the Coastal Kennels Doggie Daycare for dog(s) over 6 months of age. \_\_\_\_\_(INITIALS)

### **SCHEDULED PICK-UP:**

Owner further understands and agrees that if their dog(s) is/are not picked up by 5pm, then Owner hereby authorizes Coastal Kennels to do whatever necessary for the continued care of Owner's dog(s) and Owner agrees to pay Coastal Kennels all cost of continuing such care. \_\_\_\_\_(INITIALS)

### **RELEASE OF LIABILITY:**

Owner further understands and agrees that any behavior or health problems that develop with the their dog(s) while at Coastal Kennels will be handled and treated as deemed best by the staff, in their sole discretion. Owner expressly agrees to assume full financial responsibility for any and all expenses arising or relating thereto. \_\_\_\_\_(INITIALS)

If Owner's dog(s) become ill or injured, we will attempt to notify you, the Owner or the Emergency Contact, with the phone numbers that were provided by Owner. If we cannot reach Owner or Emergency Contact, Coastal Kennels, at its

sole discretion, may engage the services of a veterinarian and/or administer medicine or give other requisite attention to your dog(s) and the expense thereof shall be paid by the Owner. \_\_\_\_\_(INITIALS)

Owner further understands and agrees that neither Coastal Kennels nor any of its staff will be liable for any illness, injury or death of Owner's dog(s) provided that reasonable care and precautions are followed. Owner hereby releases all of them of any liability of any kind arising from or as a result of Owner's dog(s) participating in Coastal Kennels Doggie Daycare. \_\_\_\_\_(INITIALS)

**OWNER'S REPRESENTATION TO US:**

Owner represents to us that you are the Owner of the dog(s) and that you are fully authorized to enter into this Agreement. All of the information about your dog(s) in this Agreement is true, accurate and complete.

- To the best of Owner's knowledge, your dog(s) has not been exposed to Rabies, Distemper, Kennel Cough or any contagious illness within 30 days prior to beginning it's stay with us.
- To the best of Owner's knowledge your dog(s) has no illness or behavior problems (including aggressive or biting behavior), that has not been disclosed to us.
- Owner agrees to indemnify and hold us harmless from and against all loss, damage or expense, including attorney's fees, resulting from misrepresentations by you or your representatives or resulting from your dog(s) stay including, without limitation, any person claiming to be the owner of your dog(s) and any person claiming damage or injury by your dog(s). \_\_\_\_\_(INITIALS)

**MISCELLANEOUS PROVISIONS:**

This written Agreement constitutes our entire and only agreement and there are no oral agreements or understandings except as provided for herein.

- This Agreement can only be changed in writing signed by you or your Agent and by us.
- This Agreement shall be effective and binding upon all parties involved.
- The law that applies to the Agreement is the law of the state and municipality where your dog(s) is to stay and shall have exclusive jurisdiction. \_\_\_\_\_(INITIALS)
